

## **AVIATION PRICE AGREEMENT**

## Call When Needed (CWN) Helicopter

This Amendment to Agreement **DNRC-IFB-2021-0033-014**, hereinafter called the "Amendment #CPI1", is made and entered into between the Montana Department of Natural Resources and Conservation, Forestry Division, 2705 Spurgin Road, Missoula, Montana 59804, and ROTAK LLC dba ROTAK Helicopter Services, 5014 Captain Hill Court, Anchorage, Alaska 99502.

Except as amended herein, Agreement **DNRC-IFB-2021-0033-014** remains fully in effect.

The parties to this Amendment #CPI1, in consideration of the mutual covenants and stipulations, and Pursuant to Section **1.3.4 Acknowledgment of Addendum**, agree to amend the following sections of the agreement as follows:

<u>Section 1.1 Agreement Term,</u> is hereby deleted and the following inserted in its place:

<u>Section 1.1 Agreement Term</u> This contract shall take effect when signed by all parties to the agreement and terminate on June 1, 2023, unless terminated earlier in accordance with the terms of this contract (Section 18-4-313, MCA). This is the first renewal, second year of the contract with two renewals remaining per Section 1, Agreement Term.

<u>Section 4.7 Payments/Extended Standby Rates: Bid Submittal Sheet Attachment A – Aircraft & Support Vehicles</u>, is hereby deleted and the following inserted in its place:

<u>Section 4.7 Payments/Extended Standby Rates: Bid Submittal Sheet Attachment A – Aircraft & Support Vehicles.</u> Adjusted flight and daily availability rates as per all items per CPI index ending in March 2022 of 8.5%. Any new or additional equipment is also able to be added at this time. (See amended Aviation Price Agreement Submittal – Attachment A)
