¹ As the subject matter of the document may involve other Bureaus within the Division, those documents should be reviewed by that Bureau's Chief, i.e., a document involving water rights should be reviewed by Water Rights Bureau Chief

² WSB reports and data are reviewed based on type and content before release to allow quality assurance for information and quantities contained within. The minimum level of review falls under 1 of 7 categories that determine the minimum required number of staff that must review. Often internal reviews exceed the minimum requirements. All categories can, and often do, include external review by other DNRC Bureaus, cooperating agencies, or organizations involved in a project or where there are implications to the work that they conduct. This external review may be informal or adhere to the review, QA/QC guidelines of the external entity, but is NOT REQUIRED to meet WSB MINIMUM review requirements described above.
