

17. SPECIAL PROVISIONS

- The Emergency Equipment Shift Ticket OF-297 may be used to track daily usage and verified by the Government and must include the Resource Order #, and/or license plate #. The Government will track use of vehicles by and the date and time for each order on an Emergency Equipment Use Invoice (OF-286) vehicle may also be paid via agency travel or purchase credit card.
- All Use Invoices and Payment Vouchers must reflect the VIN number and license number of the vehicle and License Plate Number.
- Only full days will be paid – no prorating of the daily rate on first and last day
- All vehicles will be provided clean on the interior, washed on the exterior, with a full tank of gas and the windshield washer fluid reservoir full. The Government will make every effort to return the vehicle clean on the interior, and washed on the exterior. Refueling and cleaning fees included in the daily rate.
- All taxes and use fees are included in the daily rate.
- All terms conditions and specifications contained in DNRC-FIRE2017-1050 are attached hereto and incorporated herein by reference.
