GROUNDWATER CERTIFICATE 40E 111462-00 WAS HISTORICALLY USED FOR STOCK PURPOSES. THE POINT OF DIVERSION IS A WELL LOCATED IN THE NWNW OF SECTION 11, T18N, R43E OF GARFIELD COUNTY. HISTORICALLY 250 ANIMAL UNITS HAVE BEEN SERVED UNDER A SINGLE STOCK TANK IN THE NWNW OF SECTION 11, T18N, R43E OF GARFIELD COUNTY

PROPOSED CHANGE

THE PROPOSED CHANGE IS TO ADD 1 ADDITIONAL STOCK TANKS TO GROUNDWATER CERTIFICATE 40E 111462-00. A TOTAL OF 2 STOCK TANKS WILL BE INCLUDED IN THE SYSTEM AND THE POINT OF DIVERSION IS A WELL LOCATED IN THE NWNW OF SECTION 11, T18N, R43E OF GARFIELD COUNTY. THE STOCK WATERING SYSTEM OPERATES AT 12 GALLONS PER MINUTE. THE NEW STOCK TANK IS LOCATED IN THE SENESE SECTION 4, T18N, R43E, GARFIELD COUNTY.

In general, the department will make a preliminary determination to grant or deny this application within 120 days of the date the application is deemed correct and complete. That date is currently unknown. If the preliminary determination is to grant the application, the application will be published in the local newspaper and a notice will be sent to appropriators who, according to department records may be affected by the proposed appropriation. Individuals will have at least 15 days and no more than 60 days (specific deadline will be identified at time of notice) to submit an objection under § 85-2-308, MCA, after the application has been published in the newspaper.
