STATEMENT OF CLAIM NO. 41J 29451 00 IS A WOLSEY CREEK RIGHT CLAIMED WITH A FLOW RATE OF 10.0 CFS TO IRRIGATE 85.0 ACRES IN SECTION 27 T12N R7E. THE POINTS OF DIVERSION ARE TWO HEADGATES BOTH IN THE NE SW NE SECTION 27 T12N R7E WITH AN ASSOCIATED PERIOD OF DIVERSION AND USE OF MAY 1 TO SEPTEMBER 30. THE SOURCE IS ALSO KNOWN AS RYAN CREEK AND HAS A CLAIMED PRIORITY DATE OF JUNE 28, 1889.

PROPOSED CHANGE

APPLICANT PROPOSES TO CHANGE STATEMENT OF CLAIM NO. 41J 29451 00 BY ADDING FOUR ELEMENTS TO THE EXISTING WATER RIGHT; POINT OF DIVERSION, PLACE OF USE, PURPOSE AND STORAGE. THIS CHANGE IS BEING FILED IN CONJUNCTION WITH TWO PERMITS AND 5 OTHER CHANGES RELATED TO WATER USE FOR A PROPOSED COPPER MINE NORTHWEST OF WHITE SULPHUR SPRINGS IN MEAGHER COUNTY.

In general, the department will make a preliminary determination to grant or deny this application within 120 days of the date the application is deemed correct and complete. That date is currently unknown. If the preliminary determination is to grant the application, the application will be published in the local newspaper and a notice will be sent to appropriators who, according to the department records may be affected by the proposed appropriation. Individuals will have 45 days to submit an objection under § 85-2-308, MCA, after the application has been published in the newspaper.
