PAST USE OF WATER

STATEMENT OF CLAIM NO. 41A 110699 00 IS AN IRRIGATION RIGHT FROM LONG CREEK IN BEAVERHEAD COUNTY. THE CLAIMED PRIORITY DATE IS OCTOBER 15, 1888, WITH AN ASSOCIATED PERIOD OF USE OF MAY 1 TO SEPTEMBER 15. TWO POINTS OF DIVERSION WERE USED IN SECTIONS 16 AND 21 TO FLOOD IRRIGATE 478 ACRES IN SECTIONS 20, 21, 28 & 29, ALL IN T13S R4W.

PROPOSED CHANGE

APPLICANT PROPOSES TO MODIFY CONDITION 1.A. ON CHANGE AUTHORIZATION NO. 41A 30072650 AND MOVE THE MEASURING POINT APPROXIMATELY 2.5 MILES UPSTREAM ON LONG CREEK, TO A MEASURING STATION THAT HAS BEEN IN OPERATION FOR A DECADE. THE SITE IS IN THE NESESW SECTION 10, T13S, R4W, BEAVERHEAD COUNTY. THERE ARE FOUR INTERVENING IRRIGATION DIVERSIONS BETWEEN THE EXISTING AND PROPOSED MEASURING SITES, AND THE APPLICANT PROPOSES TO MONITOR/MEASURE TWO OF THOSE DIVERSIONS USING EXISTING FLUMES TO ACCOUNT FOR APPROPRIATIONS IN THE INTERVENING STREAM REACH. THE OTHER TWO IRRIGATION DIVERSIONS DO NOT NEED TO BE MONITORED/MEASURED BECAUSE THEY ARE ASSOCIATED WITH THE WATER RIGHT THAT WAS CHANGED TO INSTREAM FLOW BY CHANGE AUTHORIZATION NO. 41A 30072650. APPROPRIATIONS FOR IRRIGATION CANNOT OCCUR FROM THOSE TWO DIVERSIONS DURING THE PERIOD THAT DFWP LEASES THE WATER RIGHT FOR INSTREAM FLOW PURPOSES.
