STATEMENT OF CLAIM NO. 41A 110699 00 IS AN IRRIGATION RIGHT FROM LONG CREEK IN BEAVERHEAD COUNTY. THE CLAIMED PRIORITY DATE IS OCTOBER 15, 1888, WITH AN ASSOCIATED PERIOD OF USE OF MAY 1 TO SEPTEMBER 15. TWO POINTS OF DIVERSION WERE CLAIMED IN SECTIONS 16 AND 21 TO FLOOD IRRIGATE 505 ACRES IN SECTIONS 20, 21, 28 & 29, ALL IN T13S R4W.

PROPOSED CHANGE

APPLICANT IS PROPOSING TO TEMPORARILY CHANGE STATEMENT OF CLAIM NO. 41A 110699 00 FOR A PERIOD OF TEN YEARS. THE TEMPORARY CHANGE IS PROPOSED TO ACCOMODATE AN INSTREAM FLOW PURPOSE TO ENHANCE THE FISHERY IN LONG CREEK BETWEEN JULY 1 AND SEPTEMBER 15, AFTER PARTIAL SEASON IRRIGATION OCCURS IN MAY AND JUNE.
