PAST USE OF WATER

THE WATER RIGHTS INVOLVED IN THIS TEMPORARY CHANGE RENEWAL WERE ORIGINALLY USED FOR FLOOD IRRIGATION. RIGHTS 43B 122539-00, 122540, AND 122542 HAVE A PLACE OF USE (POU) OF 179 ACRES; RIGHT 43B 122544-00, OF 86.6 AC; RIGHTS 43B 122547-00 AND 122548, OF 57.5 AC. THESE ARE SUPPLEMENTAL RIGHTS, WHICH MEANS THAT THEY HAVE OVERLAPPING POU'S AND CAN BE COMBINED TO IRRIGATE ONLY OVERLAPPING PARCELS. THE POU IS LOCATED IN SECTIONS 7 AND 8, T08 S, R08 E, PARK COUNTY. THE HISTORICAL POINTS OF DIVERSION (PODS) ARE NINE HEADGATES IN SECTIONS 4, 5, 7, 8, AND 9, T08 S, R08 E, PARK COUNTY. THE SOURCE OF WATER IS CEDAR CREEK (RIGHTS 43B 12539-00, 125540, AND 125542); FIRST FORK CEDAR CREEK (RIGHT 43B 122544-00); AND SPRING CREEK (RIGHT 43B 122547-00 AND 122548).

PROPOSED CHANGE

THIS APPLICATION IS TO RENEW A TEMPORARY CHANGE. THE TEMPORARY CHANGE WAS ORIGINALLY ISSUED ON SEPTEMBER 20, 1995, FOR A PERIOD OF TEN YEARS, WITH A 10-YEAR RENEWAL IN 2005, AND AUTHORIZED THE CHANGE OF WATER RIGHTS 43B 122539-00, 122540, 155542, 122544, 122547, AND 122548. A CHANGE IN PLACE OF USE AND PURPOSE OF USE OF THE ABOVE RIGHTS WAS AUTHORIZED FOR MAINTAINING AND ENHANCING STREAMFLOWS FOR FISHERIES FROM MAY 1 TO OCTOBER 15. THE CHANGED PLACE OF USE INCLUDES CEDAR CREEK FROM A HEADGATE IN THE NENWNE OF SECTION 13, T8S, R7E, PARK COUNTY, TO THE CREEK'S CONFLUENCE WITH THE YELLOWSTONE RIVER IN THE NESENW OF SECTION 13, T8S, R7E, PARK COUNTY. THE RENEWAL PERIOD REQUESTED IS AN ADDITIONAL 10 YEARS.
