PAST USE OF WATER

A FLOW RATE OF 4,100 GALLONS PER MINUTE WAS CLAIMED FROM THE YELLOWSTONE RIVER WITH A PRIORITY DATE OF JUNE 1, 1890. WATER WAS DIVERTED INTO A PIPELINE AT A POINT IN THE SWSEW OF SECTION 24, T02 S, R09 E, PARK COUNTY. THE PURPOSE OF THE USE WAS MUNICIPAL TO SUPPLY THE CITY OF LIVINGSTON YEAR-ROUND, FROM JANUARY 1 TO DECEMBER 31. A VOLUME OF 3,148 ACRE-FEET WAS CLAIMED, OF WHICH 1,385 ACRE-FEET WAS CONSUMED.

THIS APPLICATION IS TO RENEW A TEMPORARY CHANGE. THE TEMPORARY CHANGE WAS ORIGINALLY ISSUED ON JUNE 21, 2006, FOR A PERIOD OF TEN YEARS AND AUTHORIZED THE CHANGE OF WATER RIGHT 43B 194573-00. A CHANGE IN PLACE OF USE AND PURPOSE OF USE OF THE PRECEDING RIGHT WAS AUTHORIZED FOR MAINTAINING AND ENHANCING STREAMFLOWS FOR FISHERIES IN THE SACAGAWEA LAGOON YEAR-ROUND, FROM JANUARY 1 TO DECEMBER 31. THE NEW PLACE OF USE INCLUDES THE YELLOWSTONE RIVER FROM THE HISTORIC POINT OF DIVERSION WHERE THE PIPELINE SURFACES IN THE SENENW OF SECTION 24, T02 S, R09 E, TO THE CONFLUENCE WITH THE YELLOWSTONE RIVER AT A POINT IN THE NENENW OF SECTION 18, T02 S, R10 E, PARK COUNTY. TEN ACRES OF LAWN IN THE PARK WILL BE IRRIGATED USING 55 GALLONS PER MINUTE UP TO 24.1 ACRE-FEET PER YEAR. THE RENEWAL PERIOD REQUESTED IS AN ADDITIONAL TEN YEARS.
