THIS APPLICATION IS BEING RE-NOTICED TO THE PUBLIC BY THE DEPARTMENT TO CORRECT THE PAST USE OF WATER INFORMATION. THE NOTICE PUBLISHED ON MAY 20, 2020 INCORRECTLY DESCRIBED THE PAST USE OF WATER AS BEING FOR IRRIGATION WATER DIVERTED FROM THE SAINT MARY RIVER TO WATER 200 AU VIA AN IRRIGATION DITCH.

PROPOSED CHANGE

THE APPLICANT SEEKS TO ADD NINE STOCK TANKS TO PROVIDE WATER TO 200 AU. THE PROPOSED STOCK TANKS ARE PROPOSED TO BE GENERALLY LOCATED IN SECTION 7, TWP 37N RGE 13W, GLACIER COUNTY.
