MUNICIPAL USE OF GROUNDWATER (5 MANIFOLD WELLS, 1 REDUNDANT YET TO BE DRILLED) IN SECTION 13 AND 12 OF T26N, R21W AND SECTION 7, 17, AND 18 OF T26N, R20W FLATHEAD COUNTY

PROPOSED CHANGE

THE APPLICANT PROPOSES TO CHANGE THE PLACE OF USE OF SEVEN WATER RIGHTS, ASSOCIATED WITH 5 EXISTING WELLS AND 1 REDUNDANT WELL YET TO BE DRILLED, TO REFLECT CURRENT DISTRICT BOUNDARIES AS OF MAY 15, 2020. THE APPLICANT PROPOSES TO ADD THREE POINTS OF DIVERSION (BRASS WELL GWIC NO. 79812, LAKESIDE ESTATES WELL GWIC NO. 156694, AND ONE YET TO BE DRILLED) TO UNPERFECTED PERMIT 76LJ 30147909.

ADDITIONAL INFORMATION

FLATHEAD COUNTY AUTHORIZED TWO ANNEXATIONS INTO THE DISTRICT MAY 2020. THE CHANGED PLACE OF USE REFLECTS THE NEW BOUNDARIES BASED ON THE ANNEXATIONS.

PERMIT 76LJ 30147909 WAS GRANTED FOR ADDITIONAL FLOW, BUT NO VOLUME FROM TROUTBECK RISE WELL GWIC NO. 79933 (11 GPM ADDITIONAL FLOW), HALL WELL GWIC NO. 79859 (95 GPM ADDITIONAL FLOW) AND TANK WELL GWIC NO. 160594 (40 GPM ADDITIONAL FLOW). THE APPLICANT IS REQUESTING TO ADD THE THREE ADDITIONAL SYSTEM WELLS TO THE PERMIT, SO THE WATER RIGHT REFLECTS THE MANIFOLD SYSTEM. THIS

WATER RIGHT IS CURRENTLY AT PUBLIC NOTICE. IF THE PERMIT FOR SOME REASON CAN NOT BE ISSUED THIS CHANGE AUTHORIZATION WILL BE MODIFIED; THE PERMIT WILL BE REMOVED FROM THE CHANGE AUTHORIZATION.
