4. Location affected by project: NWSESE, Section 27, Township 35N, Range 21W, Flathead County.

5. Narrative summary of the proposed project, purpose, action to be taken, and benefits:

This application is to obtain a water use permit for a well located in the Glacier National Park Compact Area in the above-described location. The applicant proposes to divert groundwater and is requesting 1.0 acre-feet per year. The proposed use is for domestic use from January 1 to December 31 inclusive of each year.

Part II. Environmental Review

1. Environmental Impact Checklist:

PHYSICAL ENVIRONMENT

WATER QUANTITY, QUALITY AND DISTRIBUTION

Water quantity - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.

Determination: Not applicable, the source is groundwater.

The Applicant will divert groundwater from a well at a rate of 25 GPM up to 1.0 AF annually. The source aquifer is potentially connected to the North Fork of the Flathead River.

Determination: No impacts

DIVERSION WORKS - Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.

The means of diversion is a well. Water will be piped to the home. The diversion, construction and operation of the system will not impact any channels or riparian areas, nor significantly modify flow.

The Montana Natural Heritage Program and DFWP websites were reviewed to determine if there are any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern", that could be impacted by the proposed project.

According to the Montana Natural Heritage Program in Township 35N, Range 21W there are eight species of concern: the Canada Lynx, Fisher, Grizzly Bear, Common Loon, Harlequin Duck, Black-backed Woodpecker, Bald Eagle, Westslope Cutthroat Trout and Bull Trout. There is one plant species of concern, the Arctic Sweet Coltsfoot. Development has occurred within this area for many years, impact to sensitive plant and animal species has most likely already occurred. The proposed use is groundwater, depletions to surface water are minimal and not anticipated to affect fish populations.

Determination: No impact

Wetlands - Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.

Determination: There are no wetlands in the area of this project.

Ponds - For ponds, consult and assess whether existing wildlife, waterfowl, or fisheries resources would be impacted.

Determination: Not applicable, the project does not involve a pond.

Determination: Soils within this area consist of alluvium made up of very gravely loamy sand, which is not sensitive to saline seep. No impact.
