### I. TYPE AND PURPOSE OF ACTION

Basin Electric Power Cooperative (henceforth referred to as proponent) has filed an application with the DNRC for the purposes of improving and utilizing an existing two track road for the purpose of maintaining an existing electrical line in the referenced tracts.

The proponent has submitted a DS-401 land use license application form. A field survey of the area has been conducted by DNRC field staff. This project does cross a return ditch owned by the Lower Yellowstone Irrigation Districts. That organization has given approval for the project. Due to the small scope of the project no additional public comment was sought.

Alternative A- Where the construction takes place there may be disturbance to the vegetation cover. The current plant community in the area is comprised mostly native species. Current Species on the site include but are not limited to Western Wheatgrass (*Agropyron smithii*), Green Needlegrass (*Stipa viridula*), Prairie cordgrass (*Spartina gracilis*) and Smooth brome (*Bromus inermis*). Minimal disturbance is expected.

Alternative A- There may be very minimal effects on any animal habitats within the boundaries of the project construction. Wildlife that inhabit the project area include deer, rodents, reptiles, migratory and resident birds. Minimal new construction would take place on the existing existing road.

Alternative A- Upon inspection of the parcels and a search of the TLMS database by the Eastern Land Office staff no findings were noted in the area of the project. A Class I (literature review) level review was conducted by the DNRC staff archaeologist for the area of potential effect (APE). This entailed inspection of project maps, DNRC's sites/site leads database, land use records, General Land Office Survey Plats, and control cards. The Class I search revealed that no cultural or paleontological resources have been identified in the APE. No additional archaeological investigative work will be conducted in response to this proposed development. However, if previously unknown cultural or paleontological materials are identified during project related activities, all work will cease until a professional assessment of such resources can be made.
