I. TYPE AND PURPOSE OF ACTION

Erik Peterson has requested permission to place improvements upon Trust Land from the DNRC for the purpose of placing and maintaining a stock water pipeline and tanks upon the tracts referenced. The pipeline will stem from an existing well north of this tract of State Trust Land. This pipeline would be installed using the static plow method and be approximately 2.5 miles in length. This pipeline should create more reliable water sources for livestock and wildlife, while creating better grazing distribution within the scope of the project. The project includes the placement of 3 stock tanks on this section of State Trust Land which will be recorded as an improvement to the lease.

II. PROJECT DEVELOPMENT

The proponent has completed the application for a land use license (DS-401). A field review of the site was completed on March 20th 2019.

Alternative A- Some soil disturbance will occur in the area of the pipeline. This disturbance should be minimal in nature. The soils at this site are a silty loam moving to moderately shallow soils as the project moves towards T12N-R43E-Sec 36. The proposed pipeline would be installed using a static method. The site should naturally recover within 2 growing seasons, a large portion of the project would take place on agricultural land.

Alternative B- No Impact.

5. WATER QUALITY, QUANTITY AND DISTRIBUTION:

Alternative A- The well feeding the pipeline will draw from available ground water resources Effects to ground water supply should be negligible. The project should not result in any degradation of water quality.

Alternative B- No Impact

6. AIR QUALITY:

What pollutants or particulate would be produced? Identify air quality regulations or zones (e.g. Class I air shed) the project would influence. Identify cumulative effects to air quality.

Alternative A- Pollutants and particulates may be increased during the construction of the project. After the completion of the project pollutant and particulate levels should return to normal.

Alternative B- No Impact

7. VEGETATION COVER, QUANTITY AND QUALITY:

What changes would the action cause to vegetative communities? Consider rare plants or cover types that would be affected. Identify cumulative effects to vegetation.

Alternative A- There may be disruption to some of the vegetation currently growing at the site. Species present on the site include Western Wheatgrass (*Agropyron smithii*), Blue Grama (*Bouteloua gracilis*), Green Needlegrass (*Stipa viridula*) Needle and Thread (*Stipa comata*), Prairie Junegrass (*Koeleria pyramidata*), Crested Wheatgrass (*Agropyron cristatum*), and Alfalfa. Vegetation disturbance should be minimal and recover naturally within 2-3 growing seasons.

Alternative B- No Impact

8. TERRESTRIAL, AVIAN AND AQUATIC LIFE AND HABITATS:

Consider substantial habitat values and use of the area by wildlife, birds or fish. Identify cumulative effects to fish and wildlife.

Alternative A- There may be minimal disruption to the wildlife that inhabit the area. Disturbance may occur while the construction is being completed. After construction is complete and the area is reclaimed there should be minimal impact. This project will also create more reliable water sources for wildlife in the area. All stock tanks will be fitted with bird ladders.

Alternative B- No Impact

9. UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES:

Consider any federally listed threatened or endangered species or habitat identified in the project area. Determine effects to wetlands. Consider Sensitive Species or Species of special concern. Identify cumulative effects to these species and their habitat.

Alternative A- A search of the Montana Natural Heritage Program Database shows six species of concern within the general area of the project. Baird's Sparrow (*Centronyx bairdii*), Bobolink (*Dolichonyx oryzivorus*), Brewer's Sparrow (*Spizella breweri*), Chestnut-collared Longspur (*Calcarius ornatus*), Ferruginous Hawk (*Buteo regalis*), Sharp-tailed Grouse (*Tympanuchus phasianellus*). While these species may be present in the general project area no direct significant impact to them or their habitat is expected. Water tanks would be fitted with bird escape ladders. Part of this project is located within Greater Sage Grouse General Habitat. The project has been submitted to the Montana Sage Grouse Habitat Conservation Program (Project #3503) for consultation and the proponent has received a consultation letter from the program. All recommendations in the consultation letter will be followed by the proponent.

Alternative B- No Impact

10. HISTORICAL AND ARCHAEOLOGICAL SITES:

Alternative A- A search of the TLMS Database shows no noted historical archaeological or paleontological resources within the scope of this project. A review by ELO field staff found no significant historical or antiquity findings within the project area.

Alternative A- Noise levels may be increased slightly and temporarily during the project but will return to normal after the completion. No lasting aesthetic impacts are expected.
