


Figure 1. Map of the proposed place of use and point of diversion.

5. Narrative summary of the proposed project, purpose, action to be taken, and benefits:

This application is to obtain a water use permit for a well located within the Glacier National Park Compact Area in the above-described location. The Applicant proposes to divert water at a rate of 25 gallons per minute (GPM) up to 1.03 acre-feet (AF) per year. The proposed appropriation is for domestic use from January 1st – December 31st and lawn and garden irrigation use from April 1st – October 31st. The DNRC shall issue a water use permit if the Applicant proves the criteria in 85-20-401 MCA are met.

Part II. Environmental Review

1. Environmental Impact Checklist:

PHYSICAL ENVIRONMENT

WATER QUANTITY, QUALITY AND DISTRIBUTION

Water quantity - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.

The Applicant proposes to divert groundwater from a well that is approximately 0.5 miles southeast of the North Fork of the Flathead River, with Spruce Creek (tributary to the North Fork; approximately 0.3 miles north of the well) flowing between the project site the river. The North Fork of the Flathead River is not identified by the DFWP as a chronically or periodically dewatered stream.

Determination: No significant impact.

Water quality - Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.

The Applicant proposes to divert and use groundwater. The reach of the North Fork of the Flathead River which may be depleted by groundwater pumping is listed as fully supporting for all beneficial uses for which it has been assessed. It is not anticipated that pumping of the

Applicant's groundwater well will have any negative impacts on the water quality of the North Fork of the Flathead River.

Determination: No significant impact.

Groundwater - *Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.*

The Applicant will divert groundwater from the aquifer at a rate of 25 GPM. The well is 124 feet deep and approximately 0.5 miles south of the North Fork of the Flathead River. Neither the National Park Service nor the Department identified this aquifer as being impaired or limited and the National Park Service did not object to this application. The flow rate will not be included in the calculation of total consumptive use for the North Fork of the Flathead River per the Glacier National Park Compact.

Determination: No significant impact.

DIVERSION WORKS - *Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.*

The well has already been drilled and the water put to beneficial use.

Determination: No significant impact.

UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES

Endangered and threatened species - *Assess whether the proposed project will impact any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern," or create a barrier to the migration or movement of fish or wildlife. For groundwater, assess whether the proposed project, including impacts on adjacent surface flows, would impact any threatened or endangered species or "species of special concern."*

The Montana Natural Heritage Program website was reviewed to determine if there are any threatened or endangered fish, wildlife, plants, aquatic species, or any "species of special concern" in Township 35N, Range 21W that could be impacted by the proposed project. 18 animal and seven plant species of concern (Tables 1 and 2, respectively) were identified within the township and range where the project is located. Of these species, the Canada Lynx (*Lynx canadensis*), the Grizzly Bear (*Ursus arctos*), and the Bull Trout (*Salvelinus confluentus*) are listed as threatened by the USFWS. An adequate quantity of water will still exist in the adjacent surface water sources to maintain existing populations of Bull Trout, should they exist there currently. The well and dwelling have already been constructed; any impacts to sensitive species have most likely already occurred and further significant impacts are not anticipated.

Determination: No significant impact.

Wetlands - Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.

Determination: N/A, project does not involve wetlands or critical riparian habitats.

Ponds - For ponds, consult and assess whether existing wildlife, waterfowl, or fisheries resources would be impacted.

Determination: N/A, project does not involve ponds.

GEOLOGY/SOIL QUALITY, STABILITY AND MOISTURE - Assess whether there will be degradation of soil quality, alteration of soil stability, or moisture content. Assess whether the soils are heavy in salts that could cause saline seep.

It is not anticipated that the proposed domestic and lawn and garden water uses will have a negative impact on the soil quality, stability, or moisture content. The soils in the project area are Typic Eutroboralfs formed from silty till. Typic Eutroboralfs have moderately low to moderately

high capacity to transmit water. Soils within the place of use are not likely susceptible to saline seep.

Determination: No significant impact.

VEGETATION COVER, QUANTITY AND QUALITY/NOXIOUS WEEDS - *Assess impacts to existing vegetative cover. Assess whether the proposed project would result in the establishment or spread of noxious weeds.*

Building construction, and thus any impact to existing vegetation, has already occurred on the property. It is not anticipated that issuance of a water use permit will contribute to the establishment or spread of noxious weeds in the project area. Noxious weed prevention and control will be the responsibility of the landowner, who must follow local noxious weed regulations.

Determination: No significant impact.

AIR QUALITY - *Assess whether there will be a deterioration of air quality or adverse effects on vegetation due to increased air pollutants.*

There will be no impact to air quality associated with issuance of the proposed permit for beneficial use of groundwater.

Determination: No significant impact.

HISTORICAL AND ARCHEOLOGICAL SITES - *Assess whether there will be degradation of unique archeological or historical sites in the vicinity of the proposed project if it is on State or Federal Lands. The project is consistent with planned land uses.

The well is drilled on private property. The proposed project will not inhibit, alter, or impair access to present recreational opportunities in the area. The project is not expected to create any significant pollution, noise, or traffic congestion in the area that may alter the quality of recreational opportunities. The proposed place of use and diversion do not exist on land designated as wilderness.

Determination: No significant impact.

No significant negative impact on human health is anticipated from this proposed use.

Determination: No significant impact.
