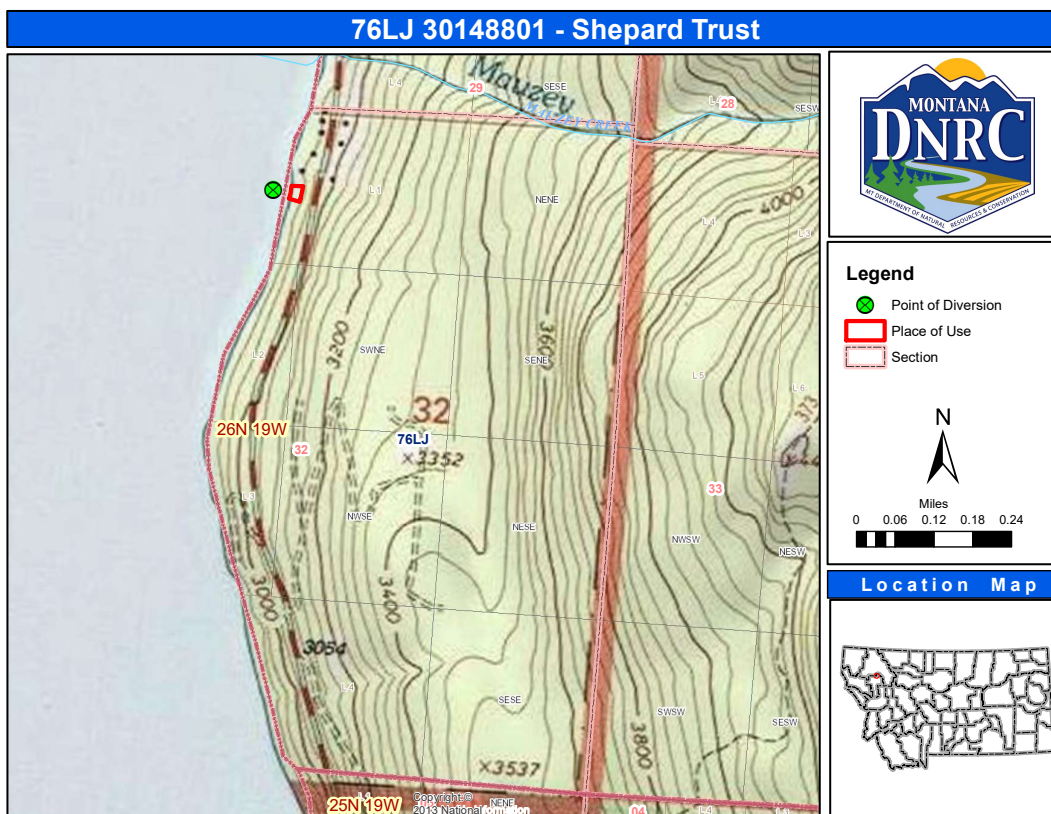

4. **Location affected by project:** Weberg Tracts Subdivision Lot 7, Government Lot 1, SENENW Section 32, Township 26N, Range 19W, Lake County, Montana.

**5. Narrative summary of the proposed project, purpose, action to be taken, and benefits:**

The Applicant proposes to divert water from Flathead Lake, by means of a pump, at a rate of 13.0 GPM up to 1.2 AF annually for domestic use from January 1 – December 31 and for irrigation of 0.07 acres of lawn & garden from April 15 – October 15. The point of diversion (POD) and place of use are located in the Weberg Tracts Subdivision Lot 7, Government Lot 1, SENENW Section 32, Township 26N, Range 19W, Lake County, Montana. The point of diversion is in the Upper Flathead River Basin (76LJ), in an area that is not subject to water right basin closures or controlled groundwater area restrictions.

The DNRC shall issue a water use permit if the applicant proves the criteria in 85-2-311 MCA are met.

**WATER QUANTITY, QUALITY AND DISTRIBUTION**

***Water quantity** - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.*

The Applicant plans to divert water from Flathead Lake, which is not on the DFWP list of chronically or periodically dewatered streams.

*Determination:* No significant impact.

**Water quality** - Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.

According to the MDEQ Clean Water Act Information Center's 2018 Water Quality Information, Flathead Lake is listed as "Not Fully Supporting" for aquatic life due to Mercury (no TMDL completed), Total Nitrogen (TMDL completed), Total Phosphorus (TMDL completed), and Polychlorinated Biphenyls (no TMDL completed). Flathead Lake's Water Quality Category is "5," meaning one or more applicable beneficial uses are impaired or threatened, and a TMDL is required to address the factors causing the impairment or threat. The proposed project will not affect water quality.

*Determination:* No significant impact.

**Groundwater** - Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.

*Determination:* N/A, this project diverts from a surface water source.

**DIVERSION WORKS** - Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.

The Applicant proposes to divert water from Flathead Lake at a maximum rate of 13.0 GPM while maintaining a minimum operating pressure of 30 pounds per square inch (psi) via a 4-inch Franklin Electric FPS 4400 10FA05S4-3W230 0.5-hp submersible pump and a Well-X-Trol pressure tank with a 30/50 psi pressure switch. The submersible pump has a 1.25-inch suction line extending into the lake near the low water mark. Water is transmitted to the pressure tank in the residence pump control room via approximately 150-feet of 1.25-inch poly pipe. From the pressure tank, water will be delivered to household fixtures for domestic use and to the various lawn and garden irrigation system components, which consists of a combination of impact and pop-up sprinklers, drip lines/emitters, and soaker hoses.

This project will not create any channel impacts, flow modifications, barriers, dams, or riparian impacts to Flathead Lake, nor will it affect any wells.

*Determination:* No significant impact.

#### **UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES**

**Endangered and threatened species** - Assess whether the proposed project will impact any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern," or create a barrier to the migration or movement of fish or wildlife. For groundwater, assess whether the proposed project, including impacts on adjacent surface flows, would impact any threatened or endangered species or "species of special concern."

The Montana Natural Heritage Program website was reviewed to determine if there are any threatened or endangered fish, wildlife, plants, aquatic species, or any "species of special concern" in Township 26N, Range 19W that could be impacted by the proposed project. 22

animal and 12 plant species of concern (Tables 1 and 2, respectively) were identified within the township and range where the project is located. Of these species, the Grizzly Bear (*Ursus arctos*), Canada Lynx (*Lynx canadensis*), and the Bull Trout (*Salvelinus confluentus*) are listed as threatened by the USFWS. An adequate quantity of water will still exist in the surface water source to maintain existing populations of Bull Trout, should they exist there currently. This area is already highly developed, and it is not anticipated that any species of concern will be further impacted by the proposed project.

*Determination: No significant impact.*

**Wetlands** - *Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.*

*Determination: N/A, project does not involve wetlands or critical riparian habitats.*

**Ponds** - *For ponds, consult and assess whether existing wildlife, waterfowl, or fisheries resources would be impacted.*

*Determination: N/A, project does not involve ponds.*

**GEOLOGY/SOIL QUALITY, STABILITY AND MOISTURE** - *Assess whether there will be degradation of soil quality, alteration of soil stability, or moisture content. Assess whether the soils are heavy in salts that could cause saline seep.*

It is not anticipated that the proposed domestic use and irrigation of approximately 0.07 acres of lawn and garden will have a negative impact on the soil quality, stability, or moisture content. The soil in the project area is Kingspoint very gravelly loam, 30 to 60 percent slopes, formed from glacial till parent material. Kingspoint very gravelly loam has moderately high to high capacity to transmit water. This soil is classified as non-saline to very slightly saline and is therefore not likely susceptible to saline seep.

*Determination: No significant impact.*

**VEGETATION COVER, QUANTITY AND QUALITY/NOXIOUS WEEDS** - *Assess impacts to existing vegetative cover. Assess whether the proposed project would result in the establishment or spread of noxious weeds.*

The residence and landscaping have been in place for at least 30 years. It is not anticipated that issuance of a water use permit will contribute to the establishment or spread of noxious weeds in the project area. Noxious weed prevention and control will be the responsibility of the landowners, who must follow local noxious weed regulations.

*Determination: No significant impact.*

**AIR QUALITY** - *Assess whether there will be a deterioration of air quality or adverse effects on vegetation due to increased air pollutants.*

There will be no impact to air quality associated with issuance of the proposed permit for beneficial use of surface water.

*Determination: No significant impact.*
