### I. TYPE AND PURPOSE OF ACTION

Poppe Cattle Company, heretofore referred to as proponent, has requested of the Department of Natural Resources and Conservation permission to license a previously constructed stock water pipeline on state owned tract T10N-R58E-Sec 36.

This project was completed in approximately 1990. This pipeline was previous unknown to the Department. DNRC staff has evaluated this site, and due to the nature of the project, no public comment was sought.

Alternative A- This is an existing pipeline; there is no disturbance. Current plant species which occupy the construction area include Western Wheatgrass (*Agropyron smithii*), Green Needlegrass (*Stipa viridula*), Needle and Thread (*Stipa comata*), Prairie Junegrass (*Koeleria pyramidata*), Blue Grama (*Bouteloua gracilis*), Fringed Sagewort (*Artemisia frigida*), Big Sagebrush (*Artemisia tridentata*), Silver Sage (*Artemesia cana*) and Downy brome (*Bromus tectorum*).

Alternative A- A search of the Montana Natural Heritage Database showed two species of concern present at the site: the sharp-tailed grouse (*Tympanuchus phasianellus*) and greater sage-grouse (*Centrocercus urophasianus*). Since this project is an existing pipeline, there should be no disturbance to wildlife. This project is located within Greater Sage Grouse General Habitat. The proponent was not submitted the project to the Montana sage Grouse Habitat Conservation Program because this project was completed in approximately 1990 and has since fully recovered.

Alternative A- No historical or archeological sites were noted within the proposed lease area upon field inspection and a review of the TLMS database. A Class I (literature review) level review was conducted by the DNRC staff archaeologist for the area of potential effect (APE). This entailed inspection of project maps, DNRC's sites/site leads database, land use records, General Land Office Survey Plats, and control cards. The Class I search revealed that no cultural or paleontological resources have been identified in the APE.
