3. Water source name: Groundwater Well

4. Location affected by project: SWSE Section 23, Township 29N, Range 15W, Flathead County.

5. Narrative summary of the proposed project, purpose, action to be taken, and benefits:

This application is to obtain a water use permit for a well located in the Glacier National Park Compact Area in the above-described location. The applicant proposes to divert water at a rate of 32 GPM up to 2.63 acre-feet per year. The proposed use is for domestic and stock use from January 1 to December 31 and an half acre of lawn and garden irrigation from April 1 - October 31 of each year.

Part II. Environmental Review

1. Environmental Impact Checklist:

PHYSICAL ENVIRONMENT

WATER QUANTITY, QUALITY AND DISTRIBUTION

Water quantity - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.

Determination: Not applicable, the source is groundwater.

Water quality - Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.

Determination: Not applicable, the source is groundwater.

Groundwater - Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.

Determination: The applicant will derive groundwater from the aquifer at a rate of 32 GPM. No known documentation of the well exists. Impacts to adjacent surface waters are not anticipated.

DIVERSION WORKS - Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.

Determination: This well has already been drilled. No significant impacts have been noted.

UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES

Endangered and threatened species - Assess whether the proposed project will impact any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern," or create a barrier to the migration or movement of fish or wildlife. For groundwater, assess whether the proposed project, including impacts on adjacent surface flows, would impact any threatened or endangered species or "species of special concern."

The Montana Natural Heritage Program and DFWP websites were reviewed to determine if there are any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern", that could be impacted by the proposed project.

According to the Montana Natural Heritage Program in Township 29N, Range 15W there is three plant species of concern: Stalk-leaved Monkeyflower (*Mimulus ampliatius*), Greville's dicranella moss (*Dicranella grevilleana*), and Fringed Chocolate Chip Lichen (*Solorina spongiosa*).

Thirteen species of concern exist: Cordilleran Forestfly (*Zapada cordillera*), Bull Trout (*Salvelinus confluentus*), Westslope Cuthroat Trout (*Oncorhynchus clarkii lewisi*), Wolverine (*Gulo gulo*), Fisher (*Martes pennanti*), Canada Lynx (*Lynx canadensis*), Grizzly Bear (*Ursus arctos*), Northern Goshawk (*Accipiter gentilis*), Brown Creeper (*Certhia americana*), Harlequin Duck (*Histrionicus histrionicus*), Varied Thrush (*Ixoreus naevius*), Pileated Woodpecker (*Dryocopus pileatus*), and Pacific Wren (*Troglodytes pacificus*). The source of water is groundwater; enough water will exist in surface sources for fish and macroinvertebrate species. This land has been developed for over 15 years any impacts to sensitive mammal species most likely has already occurred.

Determination: No impact.

Wetlands - Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.

Determination: Not applicable, project does not involve wetlands or critical riparian habitats

Ponds - *For ponds, consult and assess whether existing wildlife, waterfowl, or fisheries resources would be impacted.*

Determination: Not applicable, the project does not involve a pond.

GEOLOGY/SOIL QUALITY, STABILITY AND MOISTURE - *Assess whether there will be degradation of soil quality, alteration of soil stability, or moisture content. Assess whether the soils are heavy in salts that could cause saline seep.*

Determination: According to soil survey data provided by the NRCS, soil within the place of use consists mostly of Fluvents/alluvial fans, which are quick to drain. Soils within the place of use are not susceptible to saline seep. No degradation of soil quality shall occur.

VEGETATION COVER, QUANTITY AND QUALITY/NOXIOUS WEEDS - *Assess impacts to existing vegetative cover. Assess whether the proposed project would result in the establishment or spread of noxious weeds.*

Determination: The land use will not change so no impact is anticipated.

Determination: Adverse air quality impacts from increased air pollutants are not expected as a result of this project. No air pollutants were identified as resulting from the applicants proposed use of groundwater.

Determination: N/A, project is not located on state or federal land.
