Montana Department of Natural Resources & Conservation – Consulting Forester Directory

A forester can assist private landowners in managing their forest to meet both their short and long-term goals & objectives. Consulting Forestry services may include assistance with writing a management plan, harvesting timber, improving wildlife habitat, property mapping, or other areas of expertise. Montana DNRC's Directory of Consulting Foresters provides contact information for consulting and mill foresters as a public service. All information is provided by the professional foresters themselves and the DNRC does not verify the information provided. When hiring a forester, DNRC suggests contacting several foresters and ask for references, education and certifications, and work experience. Professional foresters should be able to provide documented work experience and education upon request. Below are definitions for consulting, mill, and DNRC Service Foresters.

Consulting Forester

Consulting foresters are independent professionals who provide expert forest management services to private landowners. Consulting foresters can help forest landowners with writing a management plan, selling timber, habitat management, and other forest management activities. Typically consulting foresters have at least a 2-year degree, or more commonly a 4-year+ degree, in forestry or a related field.

Mill Forester

Mill foresters are listed on page x of this document. Mill foresters work for forest products mills and primary purchase timber for their mill but also may provide forest management assistance to private landowners in other areas as part of the timber sale, or separately. Mills may have multiple foresters so contact information provided is for the mill company, who can connect you to a mill forester that fits your needs.

DNRC Service Foresters

Montana DNRC has Service Foresters located in offices across Montana that are available for free private landowner assistance. Service Foresters will not be able to dedicate as much one-on-one time as consulting or mill foresters but can provide expertise on a variety of topics and connect landowners to specialists and programs that fit their needs. For an initial consultation, Service Foresters generally limit their time to a few hours per ownership. Find your local DNRC Service Forester at www.dnrc.mt.gov/serviceforestry.
