Dear Unit Office Director:

I represent Spur Cross Ranch, LLC, who owns property adjoining the State Land along Axtell Anceny Road in Gallatin County. I previously expressed concerns about the abuse on the neighboring State Land to the DNRC Director on September 12, 2022. In response, on October 18, 2022, Director Kaster issued a narrow shooting closure in a small portion of the adjoining State Land tract.

The Director's response closed with a commitment to reassess the situation, and encouraged my client to call 911, or the 800-TIP-MONT line, if improper activity continued.

Three years later, it is clear the DNRC's limited action has failed. Complaints to the County, Montana Department of Livestock, MT DNRC and MT FWP have gone unheeded. If you know of any enforcement of public complaints in the last 3 years, please provide proof of same.

The overwhelming public frustration of the public abuse of State Land is evidenced by the attached: (1) petitions with over 100 signatures of nearby property owners and State Lessees, (2) photos of property damage, (3) documentation of wildland fires caused by the public, (4) map of the affected area, and (5) accounts of dead domestic horses and cattle killed by "target" shooters on State Land.

The State's inaction has also led to more negligent discharge of firearms, and dumped garbage, litter, shell casings, and metal debris, all impacting legitimate livestock operations and safe public recreation.

As I stated 3 years ago, M.C.A. Section 77-1-804 and ARM 36-25-152 provides a path for the DNRC to solve and address these issues. Clearly criteria under the Rule have been satisfied, including: (1)(b) damage to surface improvements, (1)(h) protection of public safety, (1)(k) imminent threats, caused by potential substantial public use, of immediate, irreparable property damage or bodily injury on the state tract or adjacent land. Since (1)(k) is satisfied, the criteria

for an emergency closure of shooting on all nearby state land (see map of demonstrated shooting sites) as defined by ARM 36-25-145 is also satisfied.

As such, as requested in the petitions, my client and their neighbors request an immediate emergency closure, especially given the current high fire conditions in the area, under ARM 36-25-152(11). My clients also request a permanent closure to firearm use under ARM 36-25-152(3).

I await your decision. Further delay will needlessly cause further damage and risk.

Re: State Land Use off of Axtell Anceny Road

Mr. Ingram,

In March, the Gallatin Gateway Rural Fire District responded to a wildland fire off Axtell Anceny Road. Access to the fire was severely impeded by extremely muddy road conditions, a result of snowmelt runoff. The fire occurred on your property, though it is suspected to have been initiated by individuals engaged in shooting activities in the vicinity, given the adjacent plot of Montana State Ground frequently utilized by the public for such purposes. Only one engine was able to reach the fire, becoming mired in mud before firefighting operations could commence. Consequently, all firefighters required transportation to the fire via your ranch manager's lighter pickup truck. The fire, which ultimately consumed six acres, was fully extinguished using hand tools.

The primary conclusion drawn from this incident is that if the state land site is to remain accessible for public use, the road must be upgraded to county standards and consistently maintained to ensure emergency crew access to the area. Fortunately, no injuries were sustained, and the fire was brought under control before significant damage occurred. However, in the event of a shooting accident in this area, access would have been limited to foot travel. When time is critical, reliable access is paramount.

While I do not advocate for the closure of public access to state-owned lands, this area falls within the response jurisdiction of the Gallatin Gateway Rural Fire District, and I am concerned about the potential for future emergencies in this location. The road consistently exhibits rutting and presents considerable difficulty for traversal, even during dry periods.

Any assistance you could provide in encouraging your neighboring landowners to address this issue would be greatly appreciated.

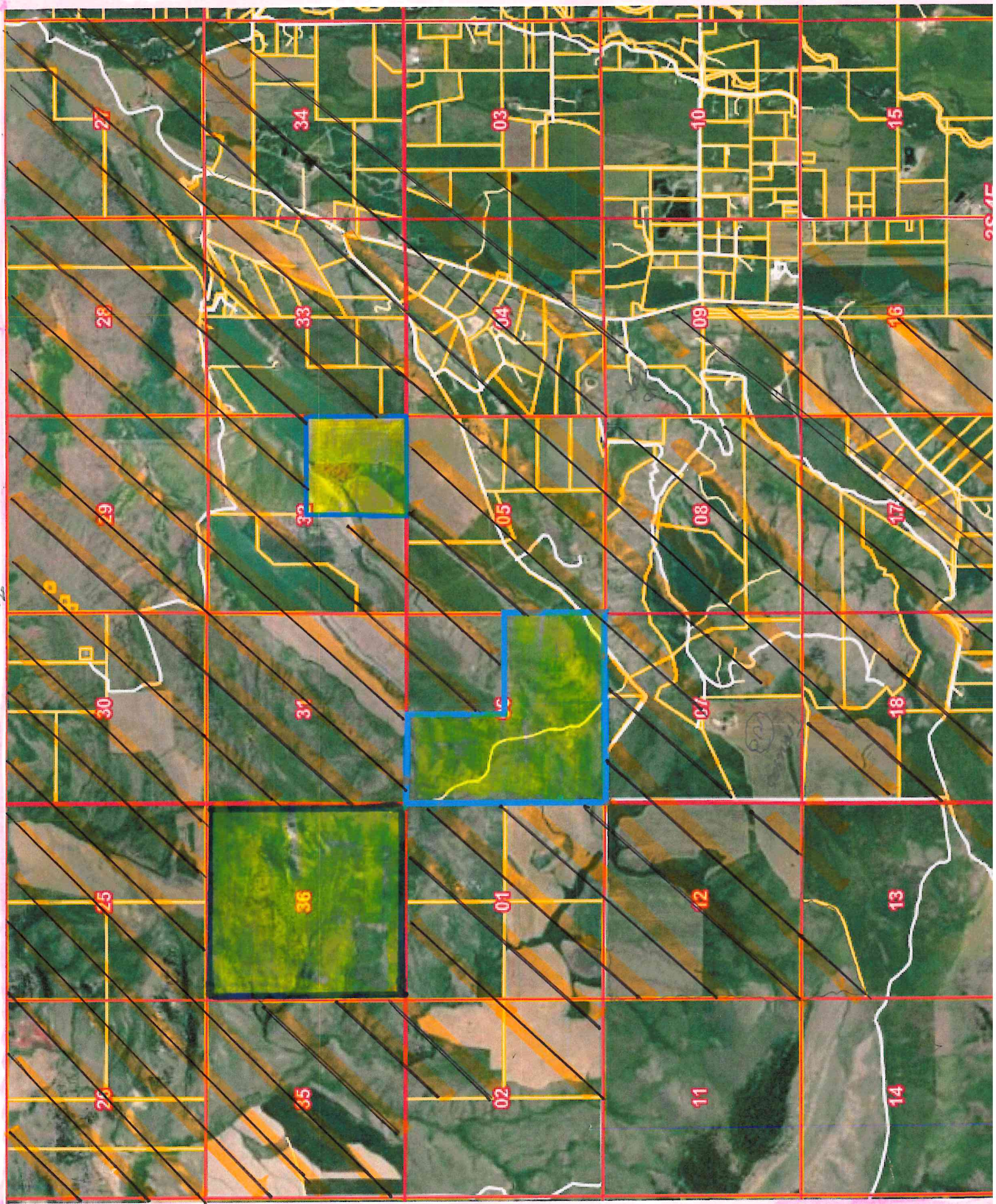

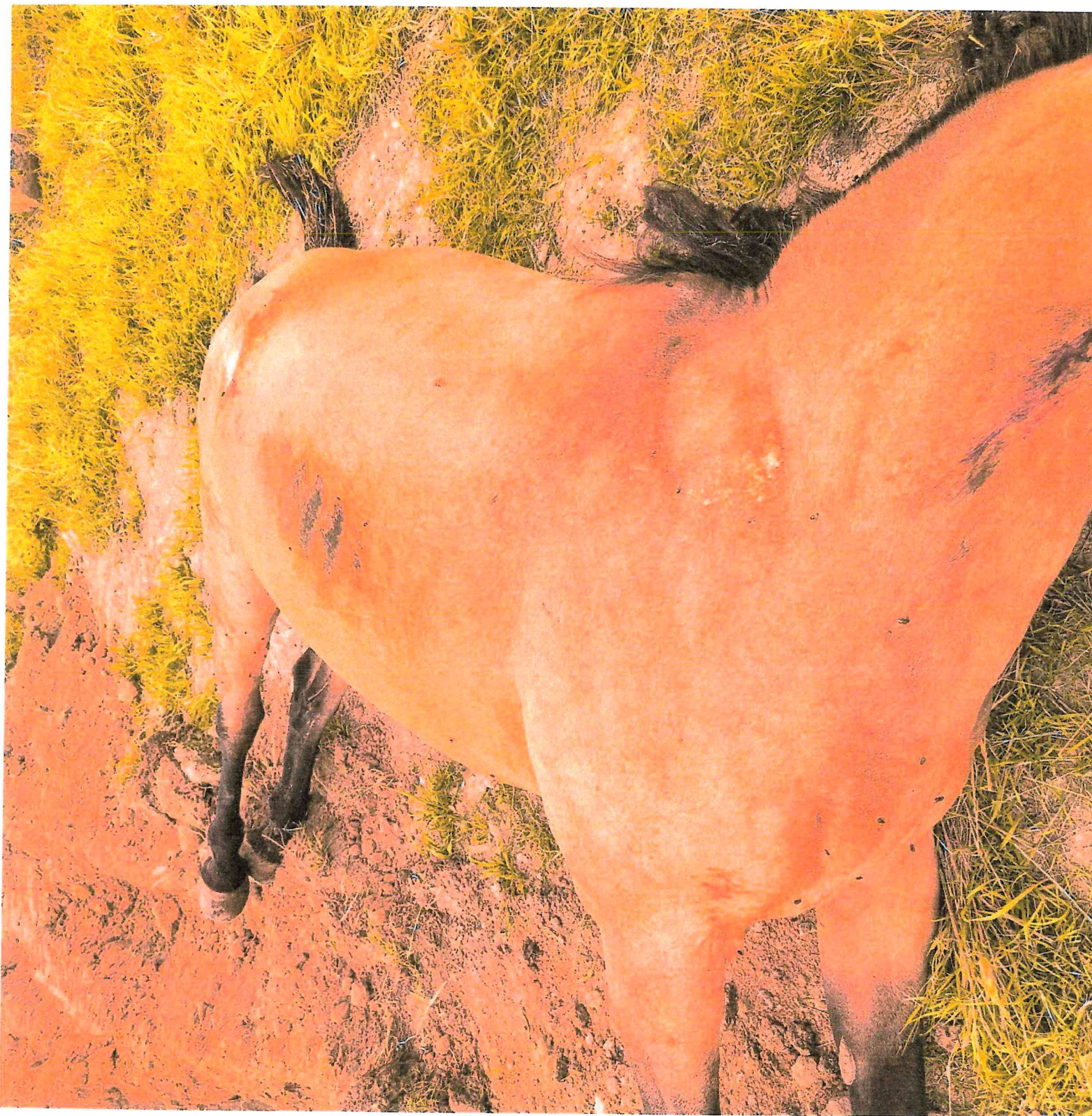

The Department is in receipt of your letter requesting an emergency closure of certain state trust lands and requesting a permanent closure to firearms. The letter does not identify a specific applicable tract by township, section, and range, however, it refers to state trust lands along Axtell Road. Based on this information, the department assumes that your petition request is referring to state trust lands located in Township 3S, Range 4E, Section 06 (3S 4E S6). Along with the letter, you have provided a map that includes three tracts, one of which is the above referenced tract, the others are 2S 3E S36, and 2S 4E S32. Your letter refers to criteria for “an emergency closure of shooting on all nearby state land (see map...”. Based on this information, the Department assumes that you have two requests that include a different makeup of state trust lands:

Permanent Closure:

- 3S 4E S6

Emergency Closure:

- 3S 4E S6
- 2S 3E S36
- 2S 4E S32



The department has reviewed your petition for an emergency closure of state trust lands located in the following sections: 3S 4E S6, 2S 3E S36, 2S 4E S32.

The petition for an emergency closure has been denied. The evidence provided does not meet the definition of “emergency” provided in administrative rule. Additionally, the fire conditions in Gallatin County are not unique to the identified tracts and do not warrant a site-specific emergency closure. The County can restrict shooting when they implement fire restrictions, and would be the best place to coordinate restrictions related to fire danger in the County.

This decision pertains only to the request for an Emergency Closure.

The petition for permanent closure of 3S 4E S6 will be reviewed during the annual cycle consistent with administrative rules. Please see ARM 36.25.152.

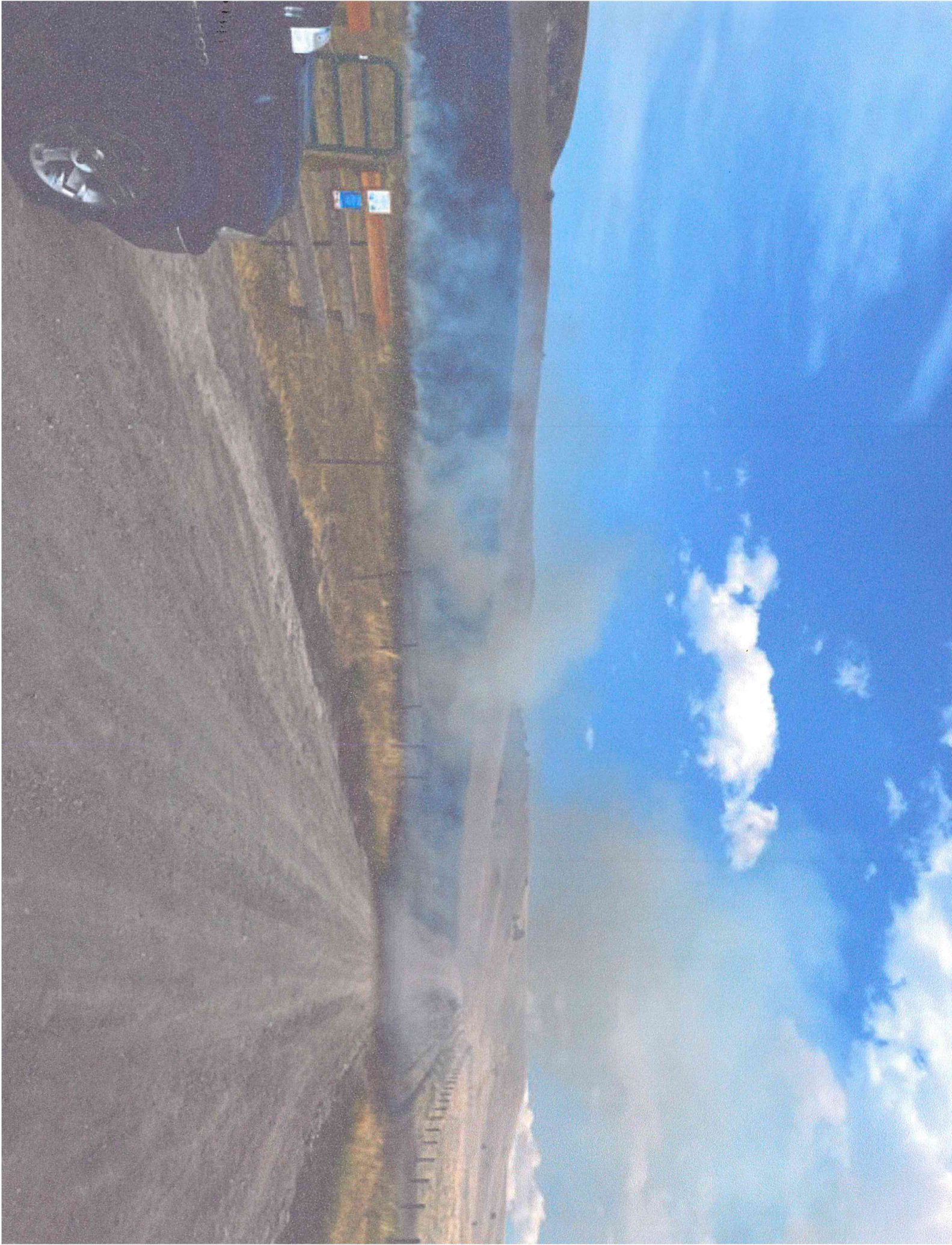

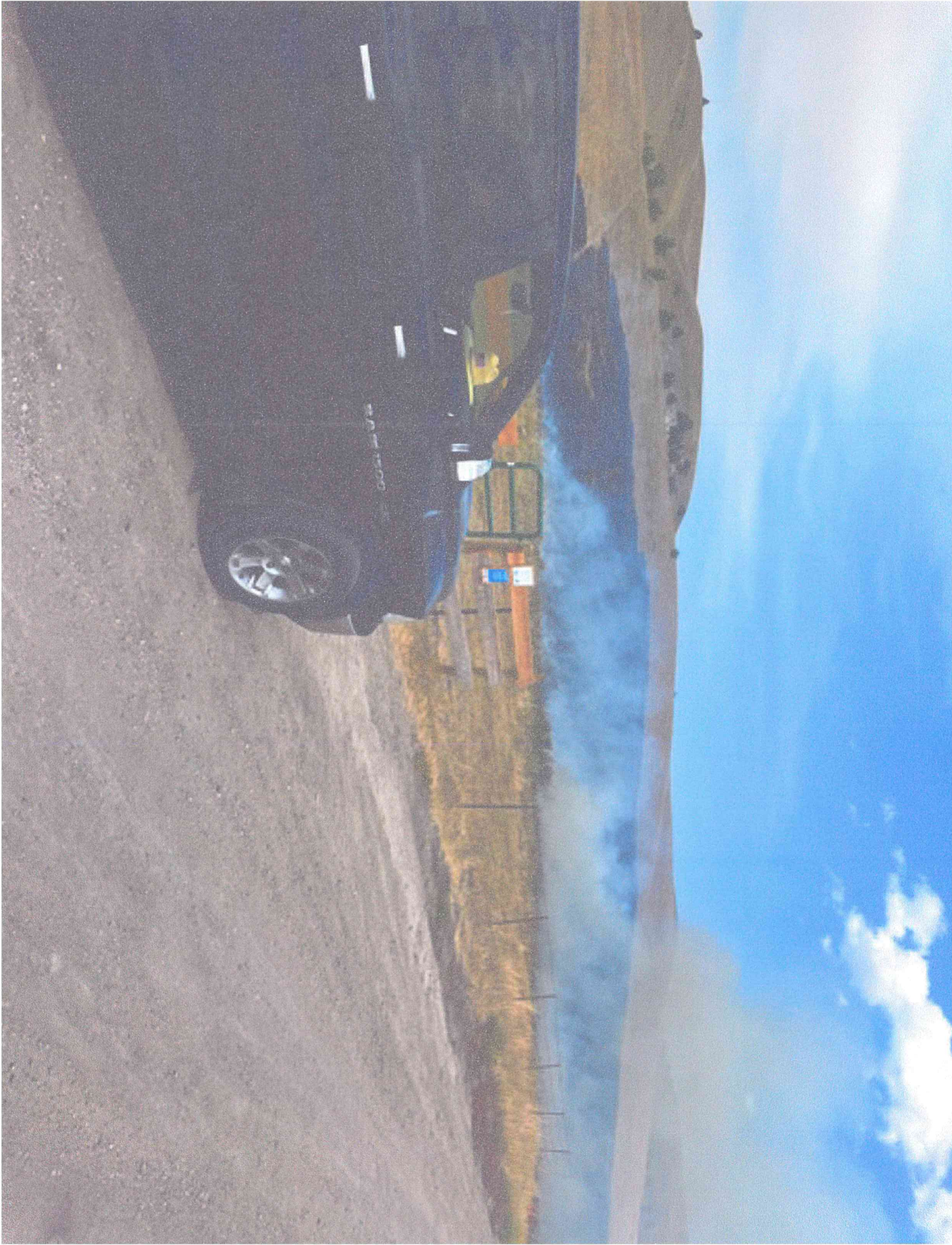

On August 18, 2025, the Montana Department of Natural Resources and Conservation ("Department") received a letter from you citing Administrative Rule 36.25.152, regarding the procedure for site specific closures.

Per administrative rule 36.25.152(3)(b), to be considered during a calendar year, the petition must be submitted by April 1 of that year, be signed by the petitioner, and must contain the following information:

- (i) Name, mailing address, and telephone number of the petitioner;
- (ii) Description of lands to which the petition applies by legal description, lease number, or other description of the location;
- (iii) The reason that the land should be closed and supporting documentation; and
- (iv) Period for which closure is sought.

The Department reviewed your petition and found it incomplete for (i) and (ii).

For the petition to be considered in the April 2026 cycle, you must update your petition to meet the requirements of the administrative rule before April 1, 2026.



For (i): Clearly identify the Petitioner for this administrative process and provide their name, address, telephone number, and signature. If there is more than one petitioner, you must provide the foregoing information for each of them.

For (ii): Based on prior conversations, the department understood your intent was to petition for permanent closure of state lands in Section 6, Township 3 South, Range 4 East. However, your submission did not clearly identify which section(s) were subject to the petition for permanent closure. You have subsequently submitted a letter dated October 9, 2025, stating that you wish to petition permanent closure for trust land in the following three sections:

Township 3 South, Range 4 East, Section 6

Township 2 South, Range 3 East, Section 36

Township 2 South, Range 4 East, Section 32

However, the language used in your October 9, 2025, letter still leaves the Department to guess whether your client seeks closure of all state lands within the foregoing sections, or merely parts of them. In curing this deficiency, the Department would accept full legal descriptions of the lands for which closure is sought. Alternatively, if closure is sought for all state lands in the foregoing sections, simply stating as much would also cure the deficiency.

In order for the Department to consider your Petition in calendar year 2026, please update your petition as discussed herein, and resubmit to the Department any time before April 1, 2026.

I received your November 5, 2025 requesting more information about the co-petitioners, and the described state land they are requesting to be closed.

I have attached the co-petitioner information with names, phone numbers and addresses.

The specific legal description of the state land that we request be closed includes NE $\frac{1}{4}$ of Section 32, Township 2 South, Range 4 East, and the W $\frac{1}{2}$ and SE $\frac{1}{4}$ of Section 6, Township 3 South, Range 4 East.
