This Litigation Update does not include bankruptcy proceedings that include state trust land leases, permits, or land use licenses as an asset of the bankruptcy estate; or administrative hearings/contested case proceedings related to state trust land leases, permits, or land use licenses.

### **GENERAL LITIGATION**

*No new cases to report.*

*Status of cases reported on October 20, 2024:*

#### ***Williams Family Trust v. DNRC and Hensley***

- Montana's First Judicial District, Broadwater County (DDV-2019-14).
- Issue: Judicial review proceeding and breach of contract claim filed by former lessee related to disputed improvement valuation.
- Current Status: Pretrial discovery related to the contract claim.

#### ***River Oxbow Ranch, et. al. v. Montana Land Board, DNRC, et al.***

- Montana's Fifteenth Judicial District, Roosevelt County (DV-2021-47).
- Issue: Lawsuit for quiet title seeking to resolve riverbed and island ownership in Roosevelt County and seeking mesne profits for royalties paid to DNRC. Montana Land Board and DNRC filed a counterclaim.
- Current Status: Identifying additional necessary parties for joinder.

#### ***McDonnel, et al v State, Montana Land Board and DNRC***

- Montana's Eighteenth Judicial District, Gallatin County (DV-16-2024).
- Issue: Lawsuit alleging nuisance, negligence, breach of fiduciary duty and seeking permanent injunction filed by multiple landowners located near a trust land parcel used for public shooting.
- Current Status: Pretrial discovery.

***Valley Garden Land and Cattle v. DNRC, AM Welles, and Riverside Contracting***

- Montana's Fifth Judicial District, Madison County (DV 29-2024-0036).
- Issue: Lawsuit challenging asphalt plant on trust land parcel alleging violation of MEPA, §§77-3-201, et seq., public participation, Water Use Act and Montana Constitution.
- Current Status: Pretrial motions and briefing.

***Valley Garden Land and Cattle v. DNRC and AM Welles***

- Montana's Fifth Judicial District, Madison County (DV 29-2023-0037).
- Issue: Lawsuit challenging gravel pit expansion on trust land parcel alleging violation of MEPA, §§77-3-201, et seq., public participation, Water Use Act and Montana Constitution.
- Current Status: Post-trial briefing related to scope of remedies.

***Held, et al. v. State***

- Montana Supreme Court (DA 23-0575).
- Issue: Lawsuit challenging MEPA exception for GHG, in part, as it relates to trust land leases that directly or indirectly result in increased CO2E. The Montana Supreme Court affirmed and remanded to resolve Plaintiffs' attorney fees claim.
- Current Status: Litigating entitlement and amount of attorney fees.

- Issue: **Ownership (POD on private land/POU on state trust land).** SBLC objected to Claim No. 41I 190751-00, which is a livestock direct from source with one or more PODs and POUs on state trust land.<sup>1</sup>
- Current Status: The parties filed a settlement agreement creating an implied water right owned by SBLC for the portion of the water right appurtenant to state trust land on April 28, 2025, and are waiting for court approval.

- Issue: Self-objection to resolve issue remarks on Claim Nos. 41S 18155-00, 41S 18200-00, 41S 21653-00, 41S 42853-00, 41S 47789-00, 41S 47811-00, 41S 47835-00, 41S 47843-00, 41S 47850-00, 41S 101593-00, 41S 101594-00, 41S 112271-00, 41S 215296-00, and 41S 30029050.
- Current Status: SBLC filed verified motions to amend the claims to resolve these self-objections on January 6, 2025, and is waiting on court approval.

#### **43P-0009-I-2025**

- Claimant: SBLC
- Objector: Sunlight Ranch Co.
- Issue: Sunlight Ranch Co. objected to Claim Nos. 43P 30112161 based on a scrivener's error in the location of the POD/POU.
- Current Status: The parties filed a settlement agreement addressing clerical errors on March 10, 2025, and was approved by the Water Court on June 9, 2025.

#### **40O-0001-I-2024**

- Claimant: Buggy Creek Livestock LLLP
- Objectors: SBLC; US BIA; US BLM
- NOIA: Assiniboine & Sioux Tribes of Fort Peck
- Issue: **Ownership (POD on private land/POU on state trust land).** SBLC objected to Claim No. 40O 30136580, which is a livestock direct from source with one or more PODs and POUs on state trust land.
- Current Status: The parties have a July 21, 2025, settlement agreement deadline.

#### **40O-0061-I-2024**

- Claimant: Antelope Ranch Inc.
- Objector: SBLC
- Issue: **Ownership (POD on private land/POU on state trust land).** SBLC objected to Claim Nos. 40O 30134608 and 40O 30134611 which are for livestock direct from source with one or more PODs and POUs on state trust land.
- Current Status: The parties have a June 23, 2025, settlement agreement deadline.

<sup>1</sup> For a livestock direct from source claim, the POU on state trust land is associated with a POD on state trust land. The POD on private land is not associated with the POU on state trust land.

- Current Status: The parties have a June 23, 2025, settlement agreement deadline.

- Issue: **Ownership (POD on private land/POU on state trust land)**. SBLC objected to Claim Nos. 40O 30136577 and 40O 30136625 which are for livestock direct from source with one or more PODs and POUs on state trust land.
- Current Status: The parties have a June 23, 2025, settlement agreement deadline.

- Current Status: The parties have a June 16, 2025, settlement agreement deadline.

- Issue: SBLC Claim No. 41F 30106559 and HRMT Land LLC Claim No. 41F 30114717 (stock watering) contain a DNRC issue remarks regarding potential overlap of the POUs.
- Current Status: The parties entered a settlement agreement June 2, 2025, pursuant to which SBLC will file a statement of non-interest on the HRMT Land LLC claim because SBLC already has a water right for the POU.

- Issue: Galzagorry Inc. Claim No. 41I 30132306 (stock watering) contains a DNRC issue remark regarding location of the POU's on both state trust land and private land. The POD for this claim is on state trust land.
- Current Status: The parties have a July 15, 2025, settlement agreement deadline.

SBLC objected to Claim Nos. 40A 211602 and 40A 211604 (surface water flood irrigation via ditch) filed by McFarland White Ranch Inc. with a POU on state trust land. McFarland White Ranch Inc. objected to SBLC being listed as co-owner on Claim Nos. 40A 30002022 and 40A 110020 (sprinkler irrigation) with a POU on state trust land.
- Current status: In 2022, MacFarland White Ranch Inc. filed a motion and statement agreeing that SBLC is co-owner of all four rights. Issues unrelated to state ownership are still being resolved.

- Current Status: The parties filed a settlement agreement regarding the priority date and creating an implied water right owned by SBLC for the portion of the water right appurtenant to state trust land on March 7, 2025, and are waiting on court approval.

- Claimant: SBLC
- Objectors: Blackfeet Tribe, US Bureau of Indian Affairs (BIA)
- Issue: Claim Nos. 41M 30109682 and 41M 301109683 pertain to water that is in a section that is partly owned by the State and partly by the Tribe. The tribe objected to all elements and ownership of SBLC's claim.
- Current Status: The parties filed a settlement agreement to remove that portion of the place of use located on Tribal land on May 5, 2025 and are waiting on court approval.

- Objectors: 71 Ranch LP; SBLC
- Issue: **Ownership (POD on private land/POU on state trust land)**. SBLC objected to Claim No. 40A 205645 based on POUs on state trust lands.
- Current Status: SBLC moved for summary judgment, but the case was stayed before 71 Ranch LP responded pending the outcome of *Schutter v. State of Mont. Bd. of Land Comm'rs*, 2024 MT 88. Following the *Schutter* decision, the parties entered into a settlement agreement.
