Call to Order, Sign-in Sheet, Agenda Changes

Denise Cook called the scheduled meeting of the Water, Wastewater and Solid Waste Action Coordinating Team (W2ASACT) to order at 10:00 am, on Tuesday, April 4, 2023. Chair Anna Miller is testifying at the 68th Session of the Montana Legislature. The draft minutes from the January 10, 2023, meeting, which were distributed to those present at DNRC and posted to the WASACT website, were approved and adopted by those attending with no revisions. There were no changes made to today's agenda. Those present at DNRC and via Zoom introduced themselves. According to the Zoom report, there were a total of 32 participants on the meeting.

As many of those who would be giving reports were at the Capital, those in attendance updated on their programs/offices if they had anything to update.

Program Updates

Roger Skogan & John Camden, MRWS

The March MRWS conference had 127 booths and 109 vendors and about 1,000 people attending. The WASACT workshop was well attended.

Craig Erickson, GWE

Craig's office is dealing with the mid-year pooling from Rural Development.

Rick Duncan gave a quick update of bills in the Legislature.

Michelle McNamee, DNRC

Michelle said we are in the final ARPA grant cycle as far as grants contracted. The ARPA website has been updated. She suggested checking out the new tools on the site. She is looking to hire one or two new grant managers. The program has over 300 awards. Rebecca Shaw-Quinones asked about progress reports and Michelle suggested to reach out to their assigned grant manager. She added that nationwide, we are ahead of the game. The Legislature acted quickly so Montana is ahead of the curve.

Rick Duncan shared BIL info relating to Regional Water projects.

Sandie Koenig said the drinking water program at DEQ will receive funding for Lead Service Lines – Emerging Contaminants. The Lead Service Line IUP is done for the first year – FY 2022 so we can move forward. In early June, we will get money out to communities. We will send out a survey on Emerging Contaminants. Then develop an IUP which shows the needs are equal to the award amount.

Rick Duncan said regarding the Coal Tax subaccount, there may be a request for funding. RBNC is seeing the high cost of materials. FPDP is 99% done. There may be a need for additional funding for Dry Prairie. They will provide modified numbers and scope to the Bureau of Reclamation.

Sandie Koenig, DEQ

Regarding FY 2024, her office is drafting an IUP for a base grant and BIL funding. Rick noted the BABA and American Iron & Steel requirements relating to AIS. Sandie added the February date is specific to USDA Rural Development. Commerce and HUD are different. May 14 the EPA and OBPP will look at project details. There are 8 sites documents. She suggested checking EPA's website and the WASACT website.

Rick added that there is non-ferrous substance in valves. Sandie added info on waivers, etc.

Mike Abrahamson, DEQ

The Clean Water – SRF program received \$3 million in CAP grants/\$10 million in Supplemental CAP grants. A new bill was signed so we need to insert into the Uniform Ap 000900.

Mike's office is trying to hire another engineer.

Mike Kropp with DEQ reported that HB 859 was tabled.

Devin Beal with MAP wanted to 'shout out' to the Department of Commerce.

Seth Shteir, DNRC

He is working on progress reports for ARPA grants.

Jason Crawford with Triple Tree Engineering asked if the ARPA deadline was the end of 2025 and Michelle confirmed. Michelle added that the FYE process has a deadline of June 30. The grant system will close in July. Claims and reimbursement requests need to be in by June 14.

Craig Erickson with GWE said April 30 is their deadline for projects.

Rick Duncan, DNRC Regional Water System Program Manager

Fort Peck-Dry Prairie – <u>Dry Prairie Rural Water</u> - Construction work continues on northwest quadrant and may be complete by the end of 2025.

Rocky Boy's-North Central – <u>Chippewa Cree Tribe</u> (Core) – Completion is expected by mid to late 2023. They are at 11 million gallons per day – may come in below this for usage. Loma and Big Sandy branches are nearly complete and could be by end of 2023. The first phase of Havre project is under design.

Central Montana RWA – the Judith-Musselshell regional system – Water could reach Harlowton by summer of 2023. Phase A of the project has been bid. Eventually water will reach Roundup. Ryegate now wants to be in the project but will not be a priority. Phase 4 from Roundup to Melstone will be first. HWY 2 west – water from Sidney to existing subdivisions.

End of updates

Next WASACT meeting is scheduled for July 11, 2023. The Montana Conference room at DNRC is reserved. A Zoom meeting will also be scheduled.

Denise thanked all for attending.
