### I. TYPE AND PURPOSE OF ACTION

The Proponent has requested to install an improvement consisting of a stock water pipeline and a stock tank on this tract of State Trust Land. The pipeline would tie into an existing line located on deeded property to the south and extend approximately 5200 feet through the tract. The line would be installed utilizing a static plow method. This stock water development project should create more reliable water sources for livestock and wildlife, while creating better grazing distribution within the scope of the project. Two stock tanks would be placed on the tract of trust land. The lessee is working on form 606-ST

### II. PROJECT DEVELOPMENT

The proponent is working on an application for improvement to state land as well as a land use license. A field review of the site was completed on June 5<sup>th</sup>, 2025, by DNRC field staff.

Alternative A- Some soil disturbance will occur in the area of the pipeline. This disturbance should be minimal in nature. The soils at this site are shallow in nature. The proposed pipeline would be installed using a static plow method and disturbance should be naturally reclaimed within one growing season.

Alternative B- No Impact.

Alternative A- The pipeline would be fed from an existing pipeline system located on surrounding BLM and Private land. The project should not result in any degradation of water quality.

Alternative A- Pollutants and particulates may be increased during the construction of the project. After the completion of the project pollutant and particulate levels should return to normal.

Alternative A- There may be disruption to some of the vegetation currently growing at the site. Species present on the site include Western Wheatgrass (*Agropyron smithii*), Blue Grama (*Bouteloua gracilis*), Green Needlegrass (*Stipa viridula*) Needle and Thread (*Stipa comata*), Prairie Junegrass (*Koeleria pyramidata*), Bluebunch Wheatgrass (*Agropyron spicata*), Little Bluestem (*Schizachyrium scoparium*) Prairie Sandreed (*Calamovilfa longifolia*), Sandberg Bluegrass (*Poa secunda*), Silver Sagebrush (*Artemisia cana*). Vegetation disturbance should be minimal and recover naturally within one growing seasons. Line would be installed using a static plow method.

Alternative B- No Impact

Alternative A- There may be minimal disruption to the wildlife that inhabit the area. Disturbance may occur while the construction is being completed. After construction is complete and the area is reclaimed there should be minimal impact. This project will also create more reliable water sources for wildlife in the area.

Alternative A- A search of the Montana Natural Heritage Program Database showed observations of four sensitive species in the general project area. Due to the small scope of this project should not cause any significant impact to this species if present. The species noted are listed below.

Townsend's Big-eared Bat - *Corynorhinus townsendii*  
Pinyon Jay - *Gymnorhinus cyanocephalus*  
Northern Hoary Bat - *Lasiurus cinereus*  
Burrowing Owl - *Athene cunicularia*

This project is not located within designated Greater Sage Grouse General, Core or Connectivity Habitat.  
Alternative B- No Impact

Alternative A. The BLM conducted a Class III inventory of cultural resources for the entire area of potential effect and recorded the Hi-Line Road (24PR3012). However, if previously unknown cultural or paleontological materials are identified during project related activities, all work will cease until a professional assessment of such resources can be made.
