I. DESCRIPTION OF ACTION

Triple derrick drilling rig to drill a single lateral horizontal Bakken Formation test, 26,430' MD/10,454' TVD.

II. PROJECT DEVELOPMENT

B. ALTERNATIVES CONSIDERED

No Action Alternative: Permit to drill the well would not be issued by BOGC.

Action Alternative: Referred to the BOGC for further environmental review.

III. IMPACTS ON THE PHYSICAL ENVIRONMENT

A. AIR QUALITY

Long drilling time: No, 5-10 days.

Unusually deep drilling (high horsepower rig): No

Emission sources: Vehicles traveling on county road to location, combustion engines on location during drilling operations. Fugitive dust from traveling operations and location during active drilling.

Possible H₂S gas production: Potentially in Mississippian formations.

In/near Class I air quality area: No.

Air quality permit for flaring/venting (if productive): Yes, DEQ air quality permit required under 75-2-211. AQB review.

Comments: No special concerns – Triple derrick drilling rig to drill a single lateral horizontal Bakken Formation test, 26,430' MD/10,454' TVD. If there are no gas gathering systems nearby, associated gas can be flared under Board Rule 36.22.1220.

B. WATER QUALITY

Salt/oil-based mud: Steel surface casing hole will be drilled with freshwater and freshwater mud system to 1950', Rule 36.22.100.1. Will drill with oil-based invert drilling fluids for the intermediate casing hole. Horizontal hole will be drilled with saltwater.

High water table: No.

Surface drainage leads to live water: No, the nearest drainage is an unnamed ephemeral drainage about 1/5 of a mile to the west. A stock pond exists in drainage about 1/2 of a mile to the south.

Water well contamination: GWIC does not list any water wells within a 1-mile radius. The topo map submitted with the permit application shows two wells labeled as monitoring wells about 1/2 of a mile to the north. GWIC lists these wells as petroleum wells.

Porous/permeable soils: No, sandy clay.

Class I stream drainage: None.

Groundwater vulnerability area: No.

Comments: Steel surface casing will be run to 1950' and cemented back to surface to protect freshwater zones (Fox Hills aquifer) in adjacent water wells, Rule 36.22.1001. Adequate surface casing and BOP equipment to prevent problems, (5,000 psi annular and double ram), Rule 36.22.1014.

C. SOILS/VEGETATION/LAND USE

Vegetation: Grassland.

Stream crossing: None anticipated.

Erosion potential: Slight, large cut of 38.1' and a large fill of 20.0' required.

Loss of soil productivity: No, location will be restored after drilling if unproductive.

Unusually large wellsite (Describe dimensions): A large wellsite for a six well pad, 430' by 650'.

Damage to improvements: Slight.

Conflict with existing land use/values: Slight.

Access road: Hwy 2 and 156th Ave. NW. A new access of 1.2 miles will be built into location.

Drilling fluids/solids: Closed loop system. Drill cuttings shall be temporarily collected in metal containers at the surface and hauled to a licensed disposal facility (WISCO Oilfield Special Waste Landfill in Williston, ND).

D. HEALTH HAZARDS/NOISE

Proximity to public facilities/residences: No residences within a 1/4 mile radius. The Town of Bainville is located about 7 miles to the southwest.

Possibility of H2S: Possibility in Mississippian formations.

Size of rig/length of drilling time: Triple derrick, 5-10 days.

E. WILDLIFE/RECREATION

Threatened or endangered species within 5 miles: Species listed as threatened or endangered in Roosevelt County, MT are the Pallid Sturgeon, Piping Plover, Whooping Crane, and Northern Myotis. The Montana Natural Heritage Program lists four (4) species of concern, the Whooping Crane, Bobolink, Snapping Turtle, and Bat Roost.

Comments: Private grasslands. There may be species of concern that may be impacted by this wellsite. We ask the operator to consult with the surface owner as to what he would like done if a species of concern is discovered at this location. The Board of Oil & Gas has no jurisdiction over private surface lands. No concerns.
