The purpose of this cost share agreement is to allow for the interagency sharing of costs to order and stage out-of-geographic area incident management teams throughout the geographic area during the 2017 fire season in order to facilitate more expeditious mobilization. Rationale for Cost Share:

All Northern Rockies agencies benefit from having an available incident management team staged within the Northern Rockies.

The costs will be split utilizing the 10-year average volume of business of the Northern Rockies Coordination Center for orders within the Northern Rockies.
