The purpose of this cost share agreement is to allow for the interagency sharing of costs to order the Colorado MMA ship for additional IR support during the 2017 fire season. The ship was ordered under a Governor to Governor compact. Following is the cost share agreement between the agencies identified above as negotiated for the following incident in accordance with the Idaho and Montana Cooperative Fire Management and Stafford Act Response Agreements.

3. Each agency will bill for their costs as outlined in the Idaho and Montana Cooperative Fire Protection and Stafford Act Response Agreement billing procedures. Federal agencies do not exchange funds.

Rationale for Cost Share:

All Northern Rockies agencies benefit from having an available IR ship working within the Northern Rockies.

The costs will be split utilizing the 10-year average volume of business of the Northern Rockies Coordination Center for orders within the Northern Rockies.






