The parties to this Amendment #2, in consideration of the mutual covenants and stipulations, and Pursuant to Section 27.2 “Entire Agreement”, agree to amend the following sections of the aforementioned contract as follows:

Section 1.1, Contract Term, is hereby deleted and the following inserted in its place:
Section 1.1, Contract Term. This contract shall take effect when signed by all parties to the agreement and terminate on June 30, 2026, unless terminated earlier in accordance with the terms of this contract. The Mandatory Availability Period (MAP) shall be ninety (90) days, beginning July 1, 2025, and ending September 29, 2025. This is the 1st renewal, 2nd year of contract with no renewals remaining per **Section 1.2, Contract Renewal.**”

The effective date of this Amendment is the last day of signing by all parties.


