SPECIAL PROVISIONS <ol style="list-style-type: none"> The Emergency Equipment Shift Ticket (OF-297) shall be used to track daily usage, shall be verified by the Government, and must include the Resource Order number, and/or license plate number. Payment for the use of vehicles will be made via an Emergency Equipment Use Invoice (OF-286), or, alternatively, the vehicle may be paid via an agency issued purchase credit card. All Use Invoices and Payment Vouchers must reflect the VIN number and license number of the vehicle. Only full days will be paid – no prorating of the daily rate on first and last day. All vehicles will be provided clean on the interior, washed on the exterior, with a full tank of gas and the windshield washer fluid reservoir full. The Government will make every effort to return the vehicle clean on the interior and washed on the exterior. Refueling and cleaning fees are included in the daily rate. All taxes and use fees are included in the daily rate. All terms, conditions, and specifications contained in the Off-Road Incident Vehicle Rental Agreement are attached hereto and incorporated herein by reference. | | | | | |
