INDIAN SPRINGS RANCH IS A COMMERCIAL GOLF COURSE AND RESIDENTIAL DEVELOPMENT LOCATED THREE MILES NORTH OF EUREKA, MONTANA, LINCOLN COUNTY IN SECTION 2, TOWNSHIP 36N, RANGE 27W AND SECTIONS 25 AND 36, TOWNSHIP 37N, RANGE 27W

Individuals will have at least 15 days and no more than 60 days (specific deadline will be identified at time of notice) to submit an objection under § 85-2-308, MCA, after the application has been published in the newspaper.
