PAST USE OF WATER

THE WATER RIGHTS AFFECTED BY THIS RENEWAL HISTORICALLY WERE DIVERTED OUT OF TIN CUP CREEK AND INTO THE WADDELL DITCH LOCATED IN THE SENENW, SEC 23, T03N, R21W RAVALLI COUNTY. THE COMBINED FLOW RATE OF THE FOUR WATER RIGHTS IS 4.32 CFS, WHICH WAS DIVERTED FOR IRRIGATION OF A TOTAL OF 183 ACRES.
