WATER RIGHT 76K 1034 HAS UNDERGONE A CHANGE AUTHORIZATION IN 2015 TO ADD AN ADDITIONAL 60 ACRES OF IRRIGATION AND ADDITIONAL POINT OF DIVERSION.
