5. **Narrative summary of the proposed project, purpose, action to be taken, and benefits:** The Applicant proposes to divert water from Lindbergh Lake by means of a pump for domestic and lawn & garden purposes. The DNRC shall issue a permit if an applicant proves the criteria in 85-2-311 MCA are met.

Part II. Environmental Review

Environmental Impact Checklist:

PHYSICAL ENVIRONMENT

WATER QUANTITY, QUALITY AND DISTRIBUTION

Water quantity - Assess whether the source of supply is identified as a chronically or periodically dewatered stream by DFWP. Assess whether the proposed use will worsen the already dewatered condition.

The Swan River is not identified as a chronically or periodically dewatered stream by DFWP.

Determination: No significant impact

Water quality - Assess whether the stream is listed as water quality impaired or threatened by DEQ, and whether the proposed project will affect water quality.

The Swan River was not assessed for any of the four beneficial uses in DEQ's 303(d) list (drinking water, primary contact recreation, agricultural, and aquatic life). No effect on water quality is anticipated as a result of the proposed change.

Determination: No significant impact

Groundwater - Assess if the proposed project impacts ground water quality or supply. If this is a groundwater appropriation, assess if it could impact adjacent surface water flows.

This proposal does not involve groundwater.

Determination: No significant impact

DIVERSION WORKS - Assess whether the means of diversion, construction and operation of the appropriation works of the proposed project will impact any of the following: channel impacts, flow modifications, barriers, riparian areas, dams, well construction.

The proposed diversion works is a ¾ HP submersible electric pump capable of diverting 12 GPM. The proposed diversion will not result in meaningful changes to the lakebed or the flow of water through Lindbergh Lake. The construction of the system will result in limited, temporary disturbances to the riparian area on the Applicant's property. No impacts to fish migration will result from this proposal. This project does not involve dams or wells.

Determination: No significant impacts.

UNIQUE, ENDANGERED, FRAGILE OR LIMITED ENVIRONMENTAL RESOURCES

Endangered and threatened species - Assess whether the proposed project will impact any threatened or endangered fish, wildlife, plants or aquatic species or any "species of special concern," or create a barrier to the migration or movement of fish or wildlife. For groundwater, assess whether the proposed project, including impacts on adjacent surface flows, would impact any threatened or endangered species or "species of special concern."

The Montana Natural Heritage Program website was reviewed to determine if there are any "threatened" or "endangered" fish, wildlife, plants, or aquatic species that could potentially be impacted by this project. "Species of special concern" were also included in this search.

According to the Montana Natural Heritage Program, observations from the past 50 years indicate that 14 animal species of concern may be found in the area of potential impact. Of these, 4 species are listed as threatened by the USFWS in this area: the Bull Trout (*Salvelinus confluentus*) Canada Lynx (*Lynx canadensis*), Grizzly Bear (*Ursus arctos*) and the Wolverine (*Gulo gulo*).

Animal species of concern include:
American Goshawk (*Astur atricapillus*)
Brown Creeper (*Certhia americana*)
Bull Trout (*Salvelinus confluentus*)
Canada Lynx (*Lynx canadensis*)
Common Loon (*Gavia immer*)
Evening Grosbeak (*Coccothraustes vespertinus*)
Fisher (*Pekania pennanti*)
Grizzly Bear (*Ursus arctos*)
Northern Hoary Bat (*Lasiurus cinereus*)
Pacific Wren (*Troglodytes pacificus*)
Pileated Woodpecker (*Dryocopus pileatus*)
Varied Thrush (*Ixoreus naevius*)
Westslope Cutthroat Trout (*Oncorhynchus lewisi*)
Wolverine (*Gulo gulo*)

The proposal is for appropriating 12 GPM up to 0.59 AF/yr for domestic and lawn and garden use. No impact to any species of concern is anticipated as a result of this proposal.

Determination: No significant impact.

Wetlands - Consult and assess whether the apparent wetland is a functional wetland (according to COE definitions), and whether the wetland resource would be impacted.

N/A – This project does not involve wetlands.

Determination: No significant impact.

The installation of a pump and buried pipe will result in temporary disruptions to vegetative cover. No establishment or spread of noxious weeds is anticipated.

Determination: No significant impact

No negative effects to air quality are expected as a result of this proposal.
