**NOTICE OF ENTRY OF INTERLOCUTORY DECREE AND NOTICE OF  
AVAILABILITY**

The Montana Water Court has entered the Interlocutory Decree for Basin 76GJ. The Interlocutory Decree includes 135 water right claims. The only water right claims in the Interlocutory Decree are those not previously decreed by the Water Court or that have issues that still need to be addressed. The Interlocutory Decree does not include water rights that were fully adjudicated in the Temporary Preliminary Decree or Preliminary Decree.

- If an abstract is included with this notice, then your claim **is** part of the Interlocutory Decree.
- If an abstract was not included with this notice, then your claim **is not** part of the Interlocutory Decree.

If you believe any water right claims in the Interlocutory Decree do not reflect historical (before July 1, 1973) beneficial use, you should file an objection by **September 21, 2026**. Objections must be filed on the forms provided by the Water Court. A request to extend the objection deadline must be filed by **September 21, 2026**. If an extension is granted it will be advertised in *The Missoulian*, *Montana Standard*, and *Phillipsburg Mail*.

**WHAT'S NEXT?**

The Water Court will be offering an informal public meeting to explain the objection process on **Wednesday, May 6, 2026, at 12:00 pm** via Zoom. If any of your water right claims in the Interlocutory Decree receive objections, the Court will notify you, and you will be allowed to file a counterobjection. After all notice periods have closed, the Water Court will address all objections, counterobjections, and issue remarks. **Make sure your address is up to date with the DNRC.**
