Pursuant to Mont. Code Ann. §§ 3-7-212, 85-2-406(4), and 85-5-101(1), Richard L. Beck (“Petitioner”), the holder of at least 15 percent of the water rights (hereinafter referred to as “Petitioner”) in Washington Creek, also known as Washington Gulch, a tributary to Nevada Creek, in the Blackfoot River Basin 76F, petitions this Court for an order to enforce the provisions of the decree entered in Geary, et al. v. David Raymond, et al., Case No. 143, Mont. 3rd Jud. Dist. Ct., Powell Co., (“Geary v. Raymond”) and to appoint a water commissioner as necessary to enforce said provisions on water rights from Washington Creek and/or Washington Gulch. Petitioner further seeks referral from this Court to the Montana Water Court to establish a tabulation of all existing rights on Washington Creek and/or Washington Gulch, within Basin 76F, and their relative priorities. Currently, Basin 76F is being adjudicated.

In support of this Petition, Petitioner states he is the owner of at least 15 percent of the Washington Creek and/or Washington Gulch water rights affected by Geary v. Raymond decree.



Petitioner respectfully requests this Court to appoint Heather McAdams, 117 Cohosset Drive, Missoula, Montana 59803, as a water commissioner to enforce the decree and act as water commissioner on Washington Creek and/or Washington Gulch. Petitioner states Ms. McAdams is a summer resident of Drummond and has experience as a water commissioner on Douglas Creek. Petitioner also respectfully requests the water commissioner be paid \$25 per hour plus the standard reimbursement rate for mileage and workers' compensation.

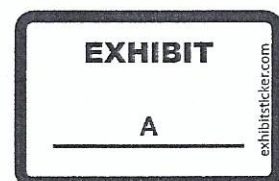
